The Charitable Checkoff program is an important way in which your Foundation is meeting critical community needs, especially now as more than 640,000 Oregonians—118,000 of them children—live with little or no health insurance and turn to the Foundation and to Lions to meet sight, hearing and health needs.

## Oregon Mandated School Vision and Hearing Screenings in 1980s

The State of Oregon required schools to screen the vision and hearing of all students in the 1980s. The Foundation has heard many different variations over the years on what the law requires, so we decided to look it up. The Foundation recently found the source of this mandate in an Oregon Administrative Rule issued by the Department of Education. The State has never defined what screenings should include. This is the only reference we have found to school screenings in Oregon law. Here is what it says:



### "Support Program, 581-022-0705, Health Services

**(1) The school district shall maintain a prevention oriented health services program for all students which provides:**

**(f) Vision and hearing screening"**

Note: (a) to (e) are deleted here, not relevant to vision and hearing.  
Stat. Auth.: ORS 326 & ORS 342; Stats. Implemented: ORS 326.051

Oregon Administrative Rules are defined as "any agency directive, standard, regulation or statement of general applicability that implements, interprets or prescribes law or policy, or describes the procedure or practice requirements of any agency."

## Foundation Hall of Fame Nominations

Nominations are now open for the Foundation's new Hall of Fame awards with a deadline of **February 14, 2011**. Inductees will be honored at the Foundation's annual statewide Hall of Fame Gala in July. Individuals or Lions Clubs may submit up to a maximum five nominations. Criteria

include: 1) Nominees will have 10 years of service to OLSHF; 2.) Up to two living inductees per year and up to two posthumous inductees will be honored per year; 3.) New in 2011: Category to induct up to one external partner (Hospital, Corporation, etc.), a staff MVP, and funder of the year; 4.) The Board of Trustees shall vote inductees into Hall of Fame.
